## Assignment Title: Hiring of consulting firm for Environment & Architecture

The Government of Sindh is committed to provide quality education to the most underserved communities of the province. For that purpose the Government has received a loan from the International Bank for Reconstruction and Development towards the cost of Sindh Education Reform Program II (SERP II), and it intends to apply part of the proceeds of this loan to payments under the contract for Public Private Partnership in Education.

Under the Public Private Partnership, the Government of Sindh has launched a pilot initiative called "Promoting Private Schooling in Rural Sindh" (PPRS) in selected districts of Sindh Province. The program is spearheaded by the Sindh Education Foundation (SEF) and implies the establishment of new schools in the most underserved and remote localities. (Khairpur, Larkana, Qambar-Shahdadkot, Dadu, Shaheed Benazirabad, Sanghar, Badin, Thatta, Umerkot, Mithi, Sujawal, Jamshoro, Jacobabad, Kashmore, Shakirpur, Ghotki, Mirpur Khas & Malir (Karachi).

The Sindh Education Foundation invites eligible firms having expertise in environment and architectural work. Firms having following expertise may submit their company profiles for shortlisting;

- 1. Facilitate development of cost efficient, environment friendly and culturally relevant school infrastructure of SEF supported schools across different districts in Sindh.
- 2. Facilitate compliance of environment and social Management Framework in SEF supported schools.
- 3. Focus and promote safe and congenial learning environment in SEF supported schools.

The eligibility for short listing is as below:

- Overall demonstrable experience of five years after registration
- Registered firm in Pakistan under the relevant laws
- Registration with relevant tax authorities
- Not black listed by the World Bank or SPPRA for their assignments
