Expression of Interest is hereby solicited from interested consultants/individuals to this effect.

Eligibility:

- 1. The Consultants working primarily in the field of documentary film production.
- 2. The Consultants must not be part of any political and religious organization(s).
- 3. The Consultants must have been active in the field of making documentaries, short animated movies and other films for at least three preceding years. An excellent track record, recognition of films at the national or international forums and/or receipt of awards would be given due weightage.
- 4. Availability of an experienced crew/team to work on this project.
- 5. The Consultants should have annual financial turnover of Rs. 1,500,000 during the last 3 years.
- * All relevant tax provisions are applicable as per SPP Rules 2010 (Amended 2017)
- * All relevant documents for evidence must be provided.

Terms of Reference (TORs) Consultancy for Making SEF Documentary

1. Background

The **Sindh Education Foundation** (a semi-autonomous organization of the Government of Sindh) is committed to educating and empowering children and communities towards social change by improving access to quality education. Ever since its establishment, the SEF endeavors have focused on enhancing opportunities for education for the growth and development of those living in remote and disadvantaged areas of the province. By now it is one of the major public-sector entities in the province with a reach out to over 550,000 students through a network of over 2,300 schools across the province of Sindh. SEF has developed expertise in evolving partnerships with individuals and Organizations over time for the purpose of improving access to quality education in the underserved areas of Sindh. SEF has an existence in the whole of the Province and operates across all twenty-nine (29) districts of Sindh.

To highlight the services rendered by the Foundation in the Education Sector spanned over a period of 25 years with a greater focus on the breakthroughs attained by the Foundation over the past few years, it is planned to produce short institutional documentary of 07 to 10-minute duration in English (sub-titled in Urdu). The documentary shall highlight the strengths of the Foundation's programs by featuring the various stakeholders and their persistent efforts.

2. Objectives:

The documentary must reflect upon SEF's strenuous efforts in furthering the agenda of education in the province of Sindh. The documentary will seek to create an understanding of the real impacts of SEF's work through interventions in remote localities through creating symbiotic public-private partnerships for education while highlighting the challenging environments; the issues of logistics; local context etc.

The overall objectives of the documentary may well be stated as:

- To assert SEF's role as a stable, resourceful stakeholder on the Education landscape of Sindh
- To highlight past, current and future interventions including teachers' capacity building and assessment, students' assessment, and induction of ICT to boost learning
- To spot SEF's recent interventions for quality improvement in infrastructure and pedagogy in schools functioning under different programs
- To emphasize upon INSTAL project's aims and objectives, and envisioned impact on overall educational scenario of Sindh
- To highlight SEF's attempt to bridge the gap between primary and post-primary education in Sindh through SEF Middle and High Schools (SMHS) Program
- To bring to light the potential of Teach for Change, a project to supplement quality of teaching at SEF supported schools by employing qualified youth
- To mention the institutional collaborations with national and international stakeholders.

3. Sample Storyline of Documentary

- Starts with the scene showing students going to schools, carrying SEF bags.
 - Voice-over introduces status of education in the rural areas of Sindh where quality education has been a dream just a few years ago
 - o A few seconds for living of persons of remotest areas such as Kachho or etc. and then children having book bags in hand are going to schools

- 1. To encompass SEF's portfolio, wide geographical area needs to be covered while filming to showcase the breadth of interventions including areas of Kachho (Dadu), coastal belt (Badin and Thatta) and other areas of Sindh.
- 2. More specifically the target districts of the all SEF supported programs will be covered at length.
- 3. For interviews SEF staff, partner institutions, officers, educationist and prominently community persons will be interviewed. SEF would facilitate in scheduling the meetings.
