The voluntary Social Welfare Agencies (Registration and Control) Rules, 1962. The Trust Act 1882. Citizen Community Boards. The Company Ordinance 1984. The Cooperative Society Act 1925.	10
9	Valid certificate by the Govt. of Pakistan/Sindh in the applied field.	10
